The Buckeye Council's single purpose is to provide programs, management and support for the various scouting units within its geographical area. As of December 31, 2010, this included 155 Cub Scout Packs consisting of 1,173 Tiger Cubs; 2,378 Cub Scouts; and 1,910 Webelos. It also included 2,684 Boy Scouts in 123 Boy Scout Troops; 340 Venture Scouts in 30 Venture Crews; and 152 Explorers in 15 Explorer Posts. This totals 8,637 youth and 323 units.
